

Electric Power	Xcel Energy. Transmission service at 230 kV is available adjacent to the site and capable of serving 100+ MW. Redundant transmission sources available approximately 2 miles to the west.			
Natural Gas	To be provided by Colorado Natural Gas. 500' +/-, existing CNG steel gas main runs through south side of property on Colfax between Imboden and Manila.			
Water	To be provided by Aurora Water. Water to be provided via existing City of Aurora system at Colorado Air & Spaceport, onsite wells and storage, and planned connection to City of Aurora system.			
Sewer	To be provided by Aurora Water. Initial phases to be served via septic tank and leach field systems. Regional treatment facility to be constructed when appropriate for long term service.			
Storm Water	To be provided by Aurora Water. Channels, storm drains, water quality and detention ponds will be constructed.			
Telecom/Fiber	Zayo, CenturyLink, and ERSTA. Zayo, Lit of Dark solution along Imboden. 100Mbs to 100Gbs+. CenturyLink point of connection at Maila/48th with 10Gbs capacity. ERSTA hub at Manila/48th with 10Gbs capacity.
