**Revised Effective Date for Change to Depreciation Rates** 

#### Dear Secretary Bose:

Pursuant to section 205 of the Federal Power Act, 16 U.S.C. § 824d, part 35 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations, 18 C.F.R. § 35.13 (2019), Xcel Energy Services Inc., on behalf of Public Service Company of Colorado ("PSCo"), submits revisions to the Xcel Energy Operating Companies Open Access Transmission Tariff ("Tariff") to change the effective date of revisions to the Tariff previously accepted by the Commission in Docket No. ER20-251-001.

As discussed herein, the revisions to the Tariff accepted in Docket No. ER20-251-001 included updated depreciation rates and removed references to completed regulatory asset amortizations to correspond with the depreciation rates to be used in retail rates by PSCo in the State of Colorado. These revisions were accepted by the Commission on January 23, 2020 with an effective date of January 1, 2020.<sup>4</sup> However, in its transmittal letter in Docket No. ER20-251-000, XES explained that while the proposed depreciation rates had been approved by the Colorado Public Utilities Commission ("CoPUC"), the effective date of these depreciation rates in retail

PSCo is the designated e-Tariff filing entity for the Xcel Energy Tariff, consistent with the requirements of Order No. 714.

rates was at the time dependent upon further action by the CoPUC.<sup>5</sup> If the CoPUC set an effective date later than January 1, 2020, XES stated that a supplemental filing would be made to request a change in the effective date of the proposed Tariff revisions to more precisely align the depreciation rates set forth in the Tariff with the CoPUC's decision.

The CoPUC has since instituted an effective date of March 1, 2020 for the depreciation rates used in PSCo's retail rates. XES is thus submitting this filing to request that the effective date of the revisions to the Tariff accepted in Docket No. ER20-251-001 be delayed until March 1, 2020 to ensure consistency between the Commission-approved depreciation rates and the CoPUC-approved depreciation rates.

To accomplish this change in effective date, XES requests that the Commission accept: (i) a new eTariff record that reverts the Tariff to the version in effect prior to the changes made in Docket No. ER20-251-001 effective as of January 1, 2020; and (ii) a second eTariff record that incorporates the changes accepted in Docket No. ER20-251-001 effective as of March 1, 2020. These changes will effectively extend the depreciation rates that were in effect before the revisions made in ER20-251-001 became effective and will result in a refund to customers. XES respectfully requests waiver of the Commission's notice requirements to implement these effective dates. <sup>6</sup>

#### I. BACKGROUND

PSCo is a wholly-owned subsidiary of Xcel Energy, a public utility holding company. PSCo is an integrated electric utility that, *inter alia*, generates, transmits, distributes, and sells electric energy at cost-based regulated rates to approximately 1.5 million retail customers in the State of Colorado subject to the regulator authority of the CoPUC.

PSCo provides open access wholesale transmission services to transmission customers under Parts II or III and ancillary-only services to ancillary service customers under Part IV of the Tariff, respectively. Approximately 82 percent of the transmission loads on the PSCo system are PSCo retail native loads; the remaining 18 percent are wholesale loads. PSCo also provides wholesale requirements sales service at cost-based rates to six municipal and cooperative customers under the Assured Power Tariff. PSCo operates a Balancing Authority Area ("BAA") in the Western Interconnection region.

The October Rate Filing and the subsequent amendment filed on December 12, 2019 are both incorporated herein by reference pursuant to 18 C.F.R. § 35.19.

Contemporaneously with this filing, XES is also submitting a filing under section 205 of the Federal Power Act to revise similarly the effective date of the depreciation rates used in PSCo's Assured Power and Energy Requirements Tariff ("Assured Power Tariff") that the Commission approved in Docket No. ER20-261-000. Those tariff revisions are proposed to be effective the same date as the revisions proposed herein.

The PSCo transmission formula rate template was initially a historic test year template established by a settlement approved by the Commission in Docket No. ER04-1174-000 *et al.* <sup>8</sup> The previously effective transmission-related depreciation rates were approved by the CoPUC in 2007 and incorporated in the PSCo transmission formula rate template in Docket No. ER08-224, effective January 1, 2007. <sup>9</sup> The depreciation rates accepted in Docket No. ER08-224-000 were then incorporated into Table 25 of Attachment O-PSCo Transmission Formula Rate Template when PSCo changed to a forward looking rate template in Docket No. ER12-1589 *et al.*, which was resolved by settlement approved by the Commission. <sup>10</sup> The settlement tariff sheets in Docket No. ER12-1589 also added certain regulatory asset amortizations, and a lengthy list of PSCo production and distribution depreciation rates, to Table 25. The currently effective depreciation rates in Table 25 were updated in Docket No. ER20-251-001 and became effective January 1, 2020. <sup>11</sup>

#### II. DESCRIPTION AND JUSTIFICATION OF PROPOSED TARIFF REVISIONS

PSCo has a longstanding practice of using the same depreciation rates for both retail electric services and wholesale services, which significantly simplifies PSCo's depreciation accounting. As indicated in the partial settlement agreement in Docket No. ER12-1589 *et al.* approved by the Commission provided that "Currently the depreciation rates for PSCo's retail and FERC jurisdictions are the same. PSCo will actively pursue any filings necessary to keep such rates synchronized." Consistent with the settlement agreement in Docket No. ER12-1589, PSCo files from time to time to incorporate depreciation rate changes approved by the CoPUC into Attachment O-PSCo of the Tariff.

On May 20, 2019, PSCo filed a new retail rate case in CoPUC Proceeding No. 19AL-0268E. In this proceeding, PSCo proposed to use the depreciation rates established in a Unanimous Comprehensive Settlement Agreement (the "16A-0231E Settlement Agreement") from 2016 that provided a full and complete resolution of all issues raised in a prior rate case in CoPUC Proceeding No. 16A-0231E. An Administrative Law Judge recommended the CoPUC accept the 16A-0231E Settlement Agreement in a Decision mailed on December 13, 2016, <sup>13</sup> and the 16A-0231E Settlement Agreement became the decision of the CoPUC as a matter of law on January 2, 2017. <sup>14</sup> The 16A-0231E Settlement Agreement provided that the depreciation and amortization expense accruals resulting from the 16A-0231E Settlement Agreement were required to be used in developing revised electric service base rates in PSCo's next general rate case. On February 11, 2020, the CoPUC issued a decision in CoPUC Proceeding No. 19AL-0268E that, *inter alia*, established an effective date of March 1, 2020 for the depreciation rates set forth in the 16A-0231E Settlement Agreement. <sup>15</sup>

Prior to the issuance of the CoPUC Decision, XES, on behalf of PSCo, filed revisions to Attachment O-PSCo of the Tariff in Docket No. ER20-251-000 to implement the depreciation rates from the 16A-0231E Settlement Agreement in time for the new depreciation rates to be incorporated into its calculation of its Estimated Rates for 2020 that were subsequently reflected in its annual update information filing that PSCo submitted to the Commission on January 10, 2020 in Docket No. ER12-1589-000. These new depreciation rates became effective January 1, 2020 pursuant to the Commission's January Letter Order. At the time XES submitted the revisions in Docket No. ER20-251-000 on October 31, 2019, the CoPUC was expected to make the new depreciation rates effective at retail around January 1, 2020. However, XES acknowledged in its filing that the proceeding remained pending before the CoPUC and that the retail effective date remained uncertain. XES accordingly stated that it would make a supplemental filing if the CoPUC established an effective date later than January 1, 2020.

Now that the CoPUC has established an effective date for the depreciation rates used in PSCo's retail rates, XES seeks to align the effective dates of the depreciation rates for both retail electric services and wholesale services by changing the effective date of the revisions accepted in Docket No. ER20-251-001 from January 1, 2020 to March 1, 2020. The proposed changes will preserve the synchronization of the depreciation rates applicable to retail and wholesale customers, consistent with the settlement in Docket No. ER12-1589.

#### III. INFORMATION RELATING TO THE EFFECT OF THE RATE CHANGE

#### A. Impact of Proposed Changes

The proposed changes will align the PSCo wholesale transmission depreciation rates and amortizations with the similar rates and amortizations to be used in PSCo retail electric rates in the State of Colorado effective on the same date the effective changes. Because the changes to the depreciation rates accepted in Docket No. ER20-251-001 resulted in a rate increase for customers, the two-month delay in making these new rates effective proposed herein will result in a refund to customers of approximately \$0.1 million. These refunds plus interest will be implemented pursuant to PSCo's Transmission Formula Rate Implementation Procedures ("Protocols") set forth in Appendix 1 of Attachment O-PSCo in the Tariff.

### **B.** Requests for Waiver

PSCo requests waiver of the requirements of 18 C.F.R. § 35.13 to the extent the rules would require the submission of cost of service statements in support of the enclosed revisions to the Tariff. The changes to the Tariff contemplated herein affect only the timing of the effectiveness of the changes the Commission accepted in Docket No. ER20-251-001. PSCo also respectfully requests that the Commission waive any requirement, including any other requirement of 18 C.F.R. § 35.13, that may be necessary to allow the proposed tariff changes to be accepted as proposed without modification or condition.

#### IV. PROPOSED EFFECTIVE DATE AND REQUEST FOR WAIVER OF NOTICE

PSCo respectfully requests that the Commission grant waiver of its sixty (60) day prior notice requirement<sup>16</sup> and allow (i) a new eTariff record that reverts the Tariff to the version in effect prior to the changes made in Docket No. ER20-251-001 to become effective January 1, 2020; and (ii) a second eTariff record that incorporates the changes accepted in Docket No. ER20-251-001 to become effective March 1, 2020.

The Commission's policy with respect to waivers of the prior notice requirement permits the Commission to grant waiver if good cause is shown. PSCo submits that good cause exists to grant the requested waiver because it will result in the consistent application of depreciation rates for both retail electric services and wholesale services, which significantly simplifies PSCo's depreciation accounting. Allowing the depreciation rates for wholesale services to match those rates used in retail electric services will also be consistent with PSCo's commitment to actively pursue measures to keep the rates synchronized pursuant to the settlement agreement accepted in

Docket No. ER12-1589. Lastly, the revised effective dates proposed herein will result in a refund to PSCo's customers, as discussed above in Section III.A.
