NOTICE OF PROCEEDING AND HEARING

NOTICE is hereby given by the New Mexico Public Regulation Commission ("Commission") of the following:

On February 7, 2012, SPS filed an Application with the Commission, pursuant to NMSA 1978, Sections 62-9-1, 62-9-3 and 62-9-6, and 17.1.2.9 NMAC and 17.9.592 NMAC, requesting (i) the issuance of a certificate of public convenience and necessity ("CCN") authorizing the construction and operation of two 230 kilovolt ("kV") transmission lines and associated substation facilities in Curry and Roosevelt Counties, New Mexico, (ii) approval of the location of the 230 kV transmission lines as described in SPS's Application and the supporting pre-filed direct testimony; and (iii) authorization for SPS to accrue AFUDC for the proposed transmission lines and substation facilities.

SPS states that the first 230 kV line will connect SPS's proposed Pleasant Hill Substation, located five miles northeast of Clovis, New Mexico, to a connection point north of Oasis Substation, located southwest of Clovis, New Mexico. The second 230 kV line will connect SPS's proposed Pleasant Hill Substation to the existing Roosevelt County Substation located south of Clovis, New Mexico. SPS states that the proposed project is necessary to provide increased reliability for Southeastern New Mexico.

The Commission has assigned Case No. 12-00027-UT to this proceeding, and all inquiries or written comments concerning this matter should refer to that case number.

The procedural schedule established for this proceeding is as follows:

- 1. Any person who desires to intervene to become a party to this case must file a Motion for Leave to Intervene, in conformity with 1.2.2.23(A) and (B) NMAC, on or before April 25, 2012, with the New Mexico Public Regulation Commission, Records Bureau, P.E.R.A. Building, P.O. Box 1269, Santa Fe, New Mexico 87504-1269.
- 2. Staff and Intervenors shall file any direct testimony on or before May 4, 2012. Any rebuttal testimony by SPS, Staff or Intervenors must be filed on or before May 14, 2012.
- 3. A public hearing will be held beginning at 9:30 A.M. on June 7, 2012 in the Ground Floor Hearing Room of the Commission's offices in the P.E.R.A. Building, 1120 Paseo de Peralta, Santa Fe, 87501, to hear and receive evidence, arguments and any other appropriate matters relevant to this proceeding.

In accordance with NMSA 1978, Section 62-9-1(C), the Commission may approve a request for a CCN and related authorizations without a formal hearing if no protest is received by the Commission within sixty days after publication of notice.

The procedural dates and requirements currently set in this case are subject to further Order of the Commission or the Hearing Examiner. Any interested person should contact the Commission for confirmation of the hearing date, time and place since hearings are occasionally rescheduled.

Anyone filing pleadings, documents or testimony shall serve a copy on all parties of record, the Commission Staff and the Hearing Examiner (i) by first class mail or hand-delivery and (ii) by e-mail. Copies served upon the Hearing Examiner shall include an electronic version of the filing in Word format. All filings shall be e-mailed on the date they are filed with the Commission.

Any person whose testimony has been pre-filed shall attend the hearing and submit to examination under oath. Unless otherwise ordered or approved by the Commission or Hearing Examiner, the questioning of a party sponsoring a witness shall be limited on direct examination to the authentication and verification of the witness' pre-filed written testimony and later to appropriate redirect examination.

Any interested person may appear at the time of hearing and make a written or oral comment pursuant to 1.2.2.23(F) NMAC without becoming an intervenor. Interested persons may also send written comments, which shall reference NMPRC Case No. 12-00027-UT, to the Commission at the mailing address set out below. All such comments will not be considered as evidence in this proceeding.
